NOTWITHSTANDING THOSE RISKS AND DANGERS IN CONSIDERATION OF THE OPPORTUNITY TO PARTICIPATE, I HEREBY (1) EXPRESSLY AND WITH FULL KNOWLEDGE ASSUME ANY AND ALL RISKS AND DANGERS ASSOCIATED WITH INLINE SKATING, INLINE HOCKEY, AND PLAYING FOR THE TEAM AND (2) RELEASE AND FOREVER DISCHARGE THE CORPORATION, THE CORPORATION'S AFFILIATES, DIVISIONS, SUCCESSORS, REPRESENTATIVES, INSURES, REINSURES, OFFICERS, DIRECTORS, EMPLOYEES (INCLUDING, WITHOUT LIMITATION, ALL COACHES AND TRAINERS), AGENTS, ATTORNEYS, OPERATORS, INSTRUCTORS, SHAREHOLDERS, AND ASSIGNS (COLLECTIVELY, THE "RELEASED PARTIES") OF AND FROM ANY AND ALL CLAIMS, DEMANDS, OBLIGATIONS, ACTIONS, MANNER OF ACTIONS, CAUSES OF ACTIONS, RIGHTS, CLAIMS FOR INDEMNITY, SUBROGATION AND/OR CONTRIBUTION, DAMAGES, SUITS, AGREEMENTS, PROMISES, LIABILITIES, CONTROVERSIES, COSTS, EXPENSES AND FEES OF ANY NATURE WHATSOEVER. WHETHER FOR COMPENSATORY DAMAGES, PUNITIVE DAMAGES OR OTHERWISE WHICH I MAY HEREAFTER ACQUIRE AGAINST THE RELEASED PARTIES (OR ANY OF THEM) IN THE EVENT I SUFFER PERSONAL INJURY, LOSS OF LIFE, PROPERTY DAMAGE TO MY EQUIPMENT WHILE PLAYING ON THE TEAM, AND/OR ACTIVITIES INCIDENTAL OR RELATED THERETO. THIS RELEASE AND INDEMNITY SHALL BE BINDING UPON ME, MY HEIRS, DEVISES, PERSONAL REPRESENTATIVES, AND ASSIGNS.
